TERMS AND CONDITIONS

1. Participants may only sell handcrafted items made by the artisan selling, not imported and/or handcrafted items by someone else. Commercial products prohibited. The Arts & Crafts by the Sea show, the Artists' Union, and the City of Ventura will keep this show Original Art oriented. All types of fine art are accepted, provided the original artisan sells it. No Artist/Vendor may sell a new product without permission from the show coordinator and the artist/vendor with a similar product. Absolutely, NO 'copy-cats'.
2. Participants agree to provide photos of their work, (for photo return, please include a self-addressed stamped envelope). Items will be juried to prevent too many vendors with similar products and to determine that the items being sold are appropriate for the show.
3. Space fees: December – April, the space fee is \$10 each Saturday. May – November, the show is open Saturdays and Sundays. During this time space fee is \$10 for one day and \$15 for two days. \*If you do not attend Saturday, Sunday is \$10. Make checks payable to: Arts & Crafts by the Sea.
4. Vendor is required to pay one year membership to the San Buenaventura Artists' Union. Membership to the SBAU also presents opportunities to display and/or sell your creations in the Gallery. New vendors may participate 2 days, on a trial basis, before paying SBAU membership fees.
5. Vendors are required to have a valid California Resale License/Seller's Permit, obtainable from the State Board of Equalization 1-800-400-7115. New vendors may participate 2 days, on a trial basis, before Seller's Permit is required.
6. Parking: You may park and unload ground level in the parking structure adjacent to the Artists' Union. Do not block access to the promenade while unloading. Parking in the loading zone is strictly prohibited. Parking validations are provided for vendors only. The Arts by the Sea show does not validate for customers.
7. Spaces are approximately 10'x10'. Wind can be a problem. All canopies must be secured with weights, sandbags, etc. Each vendor is required to set up table or selling area so that it does not restrict foot traffic through the California Street Plaza and from the Plaza to the Promenade. A 15 foot clearance between Aloha/Crown must be observed. Each vendor's area must be neat, clean and organized. Please help us maintain an aesthetic value to the Plaza.
8. City Ordinance prohibits any bells, whistles, music or verbal 'hawking' of any kind to stimulate sales or increase business.
9. Vendors agree to abide by the rules at all times and agree to conduct themselves and their business in a manner that is legal, safe and respectful of others.
